



## 2009 MARKET RULES

### GULLEY GREENHOUSE FARMERS' MARKET

6029 South Shields Fort Collins, CO 80526

Fridays from 12:00 pm until 3:00 pm

June 19<sup>th</sup> to September 25<sup>th</sup> of 2009

- Please check with Market Manager for parking and sale space assignment. After 11:00 am vendors are not guaranteed a reserved parking spot.
- Sellers may sell while setting up. NO ONE MAY LEAVE BEFORE CLOSE OF MARKET AT 3:00 PM (except for emergencies or prior Manager Approval).
- ***Sellers must sign an application stating that they will sell only goods that they or their families have produced in Colorado, or that they have bought directly from a Colorado producer.***
- A limited number of vendors will be allowed depending on space availability and uniqueness of product
- *Gulley Greenhouse sells live Plants, Bedding Plants, Herbs, Trees, Shrubs, Roses etc. No products like these will be allowed at the market.*
- Cut flowers bouquets will be allowed.
- The Market Manager may demand to see invoices for any questionable produce. Stale, unwholesome or poor quality produce may be rejected from the market.
- ***Processed food vendors must have a proper Larimer County / Colorado Health Department License and equipment to comply with Health Department guidelines.***
- A company dumpster will be available at the market. However, each vendor is responsible for cleaning its sale space or it will be charged \$20.00.
- ***Each vendor is responsible for its own Sales Taxes. A copy of sales tax license must be turned in to Market Manager with the vendor application.***
- ***All vendors must have their own liability insurance.***
- Sellers must check in and check out with the Market Manager. Vendor fees must be paid at the end of each market.
- The fee allows the vendor to use space necessary for their product. Vendors that don't respect sale space won't be allowed in the Market.
- Cash or check will be accepted for fee payment. Cash payment must have a signed receipt by the Market Manager. Any vendor writing a short check will reimburse any applicable fees to Gulley Greenhouse Farmers' Market.
- The daily fees will be \$5.00 for Vegetable growers and \$10.00 for everyone else.

- Food samples must be prepared according to Colorado Health Department Standards. Everything edible must be kept off of the ground.
- Sales by weight must be done on a scale certified by the State of Colorado.
- No seller will consume or be under the influence of alcohol or drugs or smoke while selling at the market.
- Sellers must have a sign indicating their name, town, phone number, and production methods. Any produce bought for resale must be labeled with the produce's origin.
- To assure selling space at this market, applications must be returned by June 5, 2009.
- Priority on parking and selling space size will be given to all the vendors who committed with our market for at least 10 market days.
- Seller must provide their own tables, tents, tarps, etc.
- Tents must be secured on all 4 corners.
- Gulley Greenhouse will provide on-site wagons for customers.
- Bathrooms are inside the retail store, for customers and sellers.
- At least 1 golf cart will be provided by Gulley Greenhouse for all vendors to share.
- Vendors and their employees may not bring pets to the market.
