Gulley Greenhouse Farmers' Market does not allow vendors selling Potentially Hazardous Foods (PHF) for on site consumption (classic mobile push carts). Gulley Greenhouse Farmers' Market requires that a copy of all Licenses be submitted with this application.***
- II. All vendors must keep track of food and non-food sales and pay the required Colorado and Larimer County Sales Taxes on top of the fee due each market. All VENDORS MUST PAY THEIR OWN SALES TAXES. A copy of the vendor sales tax license must be submitted with this application.***
- III. All vendors must check in with the Market Manager at the beginning of each market, to assign sale spaces and parking spaces. Also, all fees must be paid before leaving the market, Check is preferred. Cash will be accepted however a receipt signed by the Market Manager is required.***
- IV. All VENDORS MUST HAVE THEIR OWN LIABILITY INSURANCE.***
